Dear Dean Cushman:

A recent consultation of ecumenical leaders and professors at Bossey, Switzerland, has proposed the establishment of a fellowship of theological schools on a world-wide basis. As you doubtless know, the idea has come up several times in recent years (AATS Biennial, Boston, 1958; Professors of Ecumenics, Denver, 1960, et al), and it appears that the time has come for wider and more deliberate consideration of the proposal.

A copy of the Bossey proposal, in very preliminary form, is attached. We have been asked to enquire of seminaries in North America as to their interest in establishing some such association. Other persons are making similar enquiry on other continents. Replies will be collated by an international committee early in the year. If such procedure seems warranted, an international meeting of seminary representatives will be called later next year to begin work on details for constituting a world association.

We are asking now for your judgment on the following specific questions. When we have collated the replies from our sister seminaries in America, we shall be in touch with you again.

- 1. Would your seminary be in favor of the establishment of some such world association?
- 2. Would your seminary participate in preparatory steps (e.g., a representative world meeting) to work at details for a world association?
- 3. Could your seminary eventually accept some share of support for such an enterprise?
- 4. Please add any specific suggestions you may have concerning procedure for establishing a world association, and for services and structure of an ongoing association.

III. Supports

I. In principle, the central budget should be provided by the seminaries, special project funds from foundations, churches, etc.

2. For staff, offices, travel and conferences, minimum required would come

to about fifty thousand dollars.

3. For the first four years, a grant should be sought of one hundred thousand dollars, to be spent in radually decreasing amounts: possibly forty, thirty, twenty, twenty and ten thousand, respectively.

4. Quotas for each seminary should be set immediately upon consitution of the Association, or some "rule of thumb" basis, e.g., the equivalent of 1 of 1% of the amount each seminary budgets for salaries of teaching staff.

IV. Procedures

1. Assuming that this present conference is concerned not only with the "ecumenizing" of the curriculum, but also with the "ecumenizing" of the seminaries as a whole, that we ask from 5-7 members of this conference to meet with an equal number of seminary deans or presidents as a "committee of enquiry."

2. That this Committee of Enquiry then draw up and circulate a letter of enquiry to all seminaries:

describing the tentative proposal put forward by this conference concerning the creation of an Association; noting that the Committee is canvassing the seminaries to see what measure of interest there is around the world; suggesting that if the response of the enquiry justifies it a constituting conference would be soon caller; and asking each seminary to indicate whether it is interested, whether it would participate in a meeting to work at details, and, if agreed, whether it could provide a share of support for the enterprise.

- 3. The Committee of Enquiry would then correlate the responses.
- 4. If a majority of the seminaries replied favorably, the Committee should proceed with the calling of a conference, securing a grant for extrapordinary expenses involved.
- 5. In preparation for the conference (or Assembly) the Committee should prepare some details, e.g., proposals concerning constitution, principles of operation, program budget.
- 6. If constituted by the conference (or Assembly) and ratified by a reasonably workable number of seminaries, proceed with the work of the Association.

Dear Professor Tobias:

I have studied your letter related to the proposal to establish a World Association of Theological Schools. I am not prepared to say that we favor such an establishment and would wish to know a good deal more concerning the relationship of such a proposed association to the work of the World Council of Churches and to The American Association of Theological Schools.

It would seem to me that a great deal more exploration is called for if a conference leading to such an organization were to be called.

I would suggest the matter be fully aired by The American Association of Theological Schools and opportunity afforded for the matter to be assessed fully by that body and its membership before preparatory steps be taken.

The multiplication of entities and organizations is viewed with conservativism here, and among other things, it would seem to me that such an organization as is proposed might very well be a division of operation within the World Council of Churches, and therefore ought to be reviewed by the Executive Committee of the World Council.



I should explain that our previous report, which stated that 45% of our students were engaged in more than twenty hours per week of remunerative work, did not at that time take account of any distinction between"students engaged in remunerative work which constitutes their main source of income" and "students who are thus engaged twenty hours per week or more." In the meantime, with the addition of personnel to the administrative staff who have been able to give careful study to this matter, we discover that our originally stated figure is inaccurate. The correct percentage of our students engaged twenty hours or more per week in remunerative work is 29.9%. I should also indicate for your information that regulations in the Duke Divinity School restrict the academic course load of students who are remuneratively employed for twenty or more hours per week. This figure accurately represents the percent of our total student body which is engaged in twenty or more hours per week of remunerative work. Dean Cushman has requested that I invite you to telephone him at our expense if this matter requires further clarification. Dear Dr. Ziegler:

I am sorry for the unintended inaccuracy of our initial report relative to the percentage of students in more than twenty hours per week of remunerative work.

I have the copy of Mr. Harmon Smith's letter providing you with the corrected figure; namely, 29.9 per cent. I am sending you under separate cover a copy of the Divinity School Bulletin with announcements for 1959-60. There on Page 24-25 you will find the statement which regulates the limitations placed on the academic course load of students who are employed as pastors in charge, or as associate pastors.

We estimate that a pastor in charge will not spend less than 20 hours per week on his pastoral assignment.

We estimate that an associate or assistant pastor may spend from 10 to 18 hours a week in his assistant relationship.

We do not have students in other work categories exceeding 15 hours a week of outside work, to the best of our knowledge.

The paragraph on Page 24-25 reads as follows:

"Students who hold pastoral appointments or act as associate pastors, or students with substantial responsibilities apart from and beyond academic work, may not enroll for more than eleven course hours in the first semester of the Junior year, nor for more than twelve hours in the second semester of the same year, nor for more than thirteen hours in any semester thereafter, except on recommendation of the Associate Dean of Students to the Dean. The schedules of all students are subject to review and approval of the Dean and the Committee on Academic Standing."

I wish to point out that this is a restriction and a limitation over previous policy, which allowed 13 hours maximum for students, without respect to academic year.

I wish further to state that through considerable administrative re-organization, by which we have three men in charge of student work—an Associate Dean of Students, a Director of Field Work, and an Assistant Director of the Work of the Rural Church under the Duke Endowment—we are for the first time in position to "hand tallor" the academic and field work program of students. We are at this time providing the methods for managing this program, and it is our explicit intention to reduce to the minimum the amount of field work permitted to our student population.

I do feel that I should state that we are faced here, as I believe is the case with sister institutions, with an increasingly alarming sociological fact—a fact which I myself called to the attention of the Divisional Meeting of The American Association of Theological Schools when Dr. Taylor visited our Divisional Group two years ago.

That fact is that students are increasingly marrying young, many of them even during their college days, and are entering the Divinity School married, and in some instances, already with one or two children. The consequent economic pressure is obvious.

In our own case, despite our liberal provision for students by which they save on tuition, it is necessary for them to find substantial support for a family responsibility. The consequence is that both we and The Association of American Theological Schools are faced with a phenomenon to be reckoned with. Shall we adopt the rule that we will not accept married students? If we accept married students, then we must accept them on the inescapable pre-supposition that they must find substantial remunerative work. Our present policy has been that of admitting such students, and requiring them to anticipate four years instead of three years for the fulfillment of the requirements of the theological curriculum. It is my opinion that the Association will have to face the issues entailed in this situation, and that the stereotyped conceptions that may have prevailed in the past will hardly serve to adjust to the sociological realities of the present. I have personally been saying for some time that this is problem number one of American theological education today.
